 - i. As a private citizen you do not sacrifice your right to lend support to any legislative bill you deem appropriate. However, any contact of your elected representatives for a bill or ordinance already introduced on the floor or into committee of any kind, at city, county, or state levels, must be done off of grant time, and on your own private and personal time.
 - **ii.** There are currently 3 separate bills under consideration in the legislature to increase the tobacco tax by at least \$1.00.
 - 1. LB 1084: Couples a tobacco tax increase with property tax relief. The hearing on this bill will take place Tuesday, 02/13/2018. This bill appears to have the most traction for passage.
 - LB 1062: Proposes an increase in tobacco prevention funding to 2.14m, introduced by Senator McDonald (Omaha). A hearing will be held 02/15/2018 in Appropriations Committee.

e. Region 6

- i. Special thanks to subgrantees for timely submission of Quarterly Reports and TRAIN Reports.
- **ii.** Currently, the subgrantees are at 29% of spend-down, \$152,000. The Region will require spend-down plans to be submitted by 02/14/2018 of any surplus that may exist within budget.

b. TEAM Announcement

- i. Tobacco-Free Parks Policy
 - **1.** Bellevue City Council will consider an ordinance to make all parks tobacco-free as soon as February 13.
 - **2.** Murray City Council is also currently considering a tobacco-free parks policy, in some form.
- ii. World No Tobacco Day: "Bag the Butts Challenge"
 - 1. Doing a contest where teams will conduct park clean-ups and bring in tobacco-trash to be weighed at TEAM home-base.
 - **2.** The team with the heaviest weigh-in at the end of the day will win a grand prize. Each team will win some kind of prize for participating.
